

<p>Number of Staff and Equipment</p>	<p>Lincolnshire Police provides policing services to the non-metropolitan county of Lincolnshire. The police force area covers 2,292 square miles with approximately 150 miles of coastline in the east of England. Although there are some more affluent areas, Lincolnshire has a high level of poverty. Around 0.7 million people live in a mainly rural setting. Its urban areas include the city of Lincoln and the small towns of Boston, Grantham, Skegness and Spalding. The resident population is increased by university students and those who visit or travel through the county.</p> <p>The Chief Constable of Lincolnshire police is Neil Rhodes. Lincolnshire Police has an establishment of about 1,100 police officers. The force is organised into Neighbourhood Policing Teams (NPT) and Response (area cars).</p> <p>The county is divided into four districts for the purposes of policing, these are Lincoln & West Lindsey (covering Lincoln, Gainsborough, Market Rasen), North & South Kesteven (covering Grantham, Sleaford, North Hykeham, Bracebridge Heath, Market Deeping, Bourne and Stamford), Coast & Wolds (covering Skegness, Mablethorpe, Louth and Horncastle). The Lincolnshire Coast Destination Bid area is roughly aligned to the Coast policing area.</p> <p>Lincolnshire Police has many specialist departments aside from the officers and PCSOs that respond initially to calls from the public. These include the Roads Policing Unit (who also form the force's firearms response), Dog section, Public Protection Unit (including specialist sexual offences officers), Scenes Of Crime, Custody suites, and the Force Control Room. In addition to this are other support departments such as IT and HR. Officers and Police Staff forming these departments are based across the county, but most having their main office at Force Headquarters in Nettleham.</p> <p>Lincolnshire Police operates a Special Constabulary that has approximately 200 officers from the rank of Special Constable to Special Chief Officer. Officers are based throughout the county out of local police stations. Lincolnshire Special Constabulary also has offices deployed in specialist units such as wildlife crime.</p>

<p>Performance Measure</p>	<p>The Police and Crime Commissioner (PCC) has a responsibility to hold the police to account on behalf of the public. The PCC provides a link between the police and communities, working to turn local police and crime related needs and wishes into action.</p> <p>The PCC publishes a summary of Force performance information on a quarterly basis. These reports can be found at the Police and Crime Commissioner's website.</p> <p><u>Crime Statistics</u></p> <p>You can find crime statistics for all the neighbourhood policing areas in Lincolnshire at www.police.uk.</p> <p><u>Her Majesty's Inspectorate of Constabulary (HMIC)</u></p> <p>Her Majesty's Inspectorate of Constabulary (HMIC) make independent assessments on police forces and policing activity. They look at neighbourhood teams to serious crime and the fight against terrorism.</p> <p>HMIC has developed the 'Crime and Policing Comparator' that provides comparison data on:</p> <ul style="list-style-type: none"> • recorded crime and anti-social behaviour (ASB), • quality of service, • finances and • workforce numbers. <p>HMIC validates and publishes this data, which is submitted by police forces. <p>Non Compliance Procedure</p>	<p>The Lincolnshire Police Performance Unit supports delivery of the force objectives through a range of functions that inform internal and external stakeholders around the performance of the force:</p> <ul style="list-style-type: none"> ▪ Performance management information is used by force personnel in the planning of operational policing activity; by senior managers and the Police and Crime Commissioner to assist in longer term strategic planning; by partners to inform their decision making; and by the Home Office to assess force performance compared to our peers. ▪ The unit is responsible for establishing and monitoring standards of performance in key areas of business and collating data regarding recorded information (such as crime and incident records), victim satisfaction and public perception. ▪ Support is provided to all business areas, our strategic partner and partnerships in the analysis of the above data, interpreting a broad range of information, ensuring consistency and quality, and providing an evidence base for the allocation of resources. ▪ The Unit ensures that statutory and government requirements are met and identifies and shares data with partner agencies in the interests of
