Number of Staff and Equipment	<ul style="list-style-type: none">• 13 members of staff in the Area 2 team.• Staff are shifted to work from 6am – 9pm (summer shift) and 6am-5pm (winter shift), 7 days a week, 365 days a year.• Fleet = 2 x Caged Tipper, Crew Cab Tipper (Flatbed), Berlingo Van with hook, Berlingo Van, Ifor Williams General Duty Trailer, Indespension Trailer, Massey Ferguson Tractor, Kawasakil Mule, Barber Surf Rake, Water Bowser• Plant: strimmers, hedge trimmers, pole saws, spraying equipment, mowers, mechanical spreaders, pressure washers, spade, shovel, rakes, hoes, etc.
Specification	<ul style="list-style-type: none">• The Area 2 team cover 18,597 hectares which includes; Mablethorpe and Sutton on Sea.• Based at Mablethorpe Depot: The Boulevard, Mablethorpe.• The team are responsible for the following key duties ; removal of litter from footpaths, public roads and public open spaces, empty litter and dog bins, street sweeping (mechanical and by-hand), removing fly tipping from public owned land and the highway, removal of graffiti and fly-posting from council owned properties, the collection of dead animals from the public highway, the cleansing of public conveniences; 7 facilities in Area 2 which open from 7am – 8pm, the cleansing of all council owned beaches and foreshores (a 6 mile stretch), grounds maintenance operations in all council owned parks playgrounds and open spaces, maintenance of bowling greens, seasonal planting and maintenance of decorative coastal display beds, shrub bed maintenance, rose planting and maintenance, formal and informal garden maintenance, hedge cutting, tree planting, maintenance and inspection and weed control (spraying, strimming) on council owned land, assist Council organised events and care-take council owned buildings.• The management of the grass cutting contract for Council owned land.• The management of Council owned trees.• Dog Warden Provision: 1x member of staff the covers the entire district of 700sqmiles.
