The team are responsible for the following key duties ; removal of litter from footpaths, public roads and public open spaces, empty litter and dog bins, street sweeping (mechanical and by-hand), removing fly tipping from public owned land and the highway, removal of graffiti and fly-posting from council owned properties, the collection of dead animals from the public highway, the cleansing of public conveniences; 8 facilities in Area 3/4 which open from 7am – 8pm, the cleansing of all council owned beaches and foreshores, grounds maintenance operations in all council owned parks playgrounds and open spaces, rose planting and maintenance, formal and informal garden maintenance, hedge cutting, tree planting, maintenance and inspection and wead control (spraying, strimming) on council owned buildings.
